The Board of Supervisors Meeting for Wednesday, December 21, 2022 was held at the Tyrone Township Municipal Building, 5280 Old Harrisburg Road, York Springs, PA 17372, Adams County, Pennsylvania.

<u>Call to Order:</u> Mosley called the meeting to order at 6:00 PM. Pledge of Allegiance: Mosley led the Pledge of Allegiance.

## **Approval of Board of Supervisors Meeting Minutes:**

Dashoff made a motion to approve the minutes for the December 7, 2022 Board of Supervisors meeting. Seymore seconded the motion. A vote was taken and the motion carried unanimously.

#### **Approval and Payment of the Accounts Payable Invoices:**

Seymore made a motion to execute the Hamilton and Musser Engagement Letter for the 2022 Audit. Dashoff seconded the motion. A vote was taken and the motion carried unanimously.

### 2023 Township Engineer Designation:

Dashoff made a motion to designate Keller Engineers as the Township Engineer for 2023. Seymore seconded the motion. A vote was taken and the motion carried unanimously.

#### Hillandale Site 1 Investigation:

The Board decided not to participate in the investigation of the Hillandale Site 1 building collapse, but is aware of this investigation occurring.

# **Public Participation:**

- Mr. Heller inquired regarding the location of the Township's EOC. Mosley answered that it is located at the
  Township EMA's residence; the Township determined it be kept there so that the EMA may respond quickly to
  emergencies with the EOC. Dashoff indicated that there is not a place to store the EOC at the Township Building.
  The Northern Adams Regional Emergency Management Association (NAREMA) has indicated an interest in possibly
  sharing the EOC among its municipalities and the Board is waiting to see if other NAREMA municipalities would be
  interested in participating in the effort.
- Mr. Richwine inquired regarding the two (2) check runs monthly and one (1) Board meeting to approve them in 2023. McFadden indicated that the Board will be considering establishing a policy for this at the January 3, 2023 Board meeting, at which this matter will be on the agenda.
- Mr. Richwine inquired regarding who Keller Engineers is. McFadden responded that Keller Engineers purchased William F. Hill and Associates, the Township's long-time Engineer, so it is the same company with the same individuals as the Township has had.
- Mr. Heller stated that three (3) buildings look like they have collapsed at the Hillandale site on Spicer Road. McFadden indicated that a building permit has recently been issued for this demolition.
- Mr. Richwine inquired why Hillandale continues requesting time extensions for the Site 3 Plan. Mosley indicated that we do not know.

## Adjournment:

Dashoff made a motion to adjourn at 6:45 PM and Seymore seconded the motion. A vote was taken and the motion carried unanimously.
