

**MINUTES OF MEETING OF  
TYRONE TOWNSHIP BOARD OF SUPERVISORS  
ADAMS COUNTY, PENNSYLVANIA  
June 8, 2022**

The Board of Supervisors Meeting for Wednesday, June 8, 2022 was held at the Tyrone Township Municipal Building, 5280 Old Harrisburg Road, York Springs, PA 17372, Adams County, Pennsylvania.

**Members Present:** Chairman Russ Raub, Supervisor Rosalie Dashoff, Secretary Sydney McFadden

**Others in Attendance:** Deputy Chief Wendell Herr – Heidlersburg Area Civic Association Fire Company, David Richwine

**Call to Order:** Raub called the meeting to order at 6:00 PM.

**Pledge of Allegiance:** Raub led the Pledge of Allegiance.

**Approval of Board of Supervisors Meeting Minutes:**

Dashoff made a motion to approve the minutes for the May 25, 2022 Board of Supervisors meeting. Raub seconded the motion. A vote was taken and the motion carried unanimously.

**Organizational Announcements:**

- ***District 3:*** The On-Lot Sewage Management System (OLMS) District 3 deadline for inspection is June 30, 2022.

**Old Business:**

**Community Media:**

No action was taken on this matter. The Board will not take up this matter again until it hears from Community Media.

**District 3 On-Lot Septic System Update:**

The Township is making an extra effort to remind OLMS owners in District 3 of their required inspection and is hopeful that this will result in more compliance. Tomorrow, every property owner that the Township believes has an OLMS in District 3 that the Township does not have record of being inspected will be mailed a reminder letter, list of the 2022 Tyrone Township Registered Septic Pumper/Haulers, and a 3" x 5" postage paid card to be completed and returned to the Township reporting that either their OLMS was inspected or is scheduled for inspection. The Township has not yet received notification of OLMS inspection for 108 total properties in District 3. 132 mailings will be issued, 24 of which have more than one address. On June 10, 2022, a Public Notice will appear in the *Gettysburg Times* conveying a reminder to OLMS owners in District 3.

**Road Project Quotes and Award:**

Dashoff made a motion to award the Chestnut Hill Road Reconstruction Labor and Equipment quote to Clearview Excavation, which provided the low quote of \$21,000.00. Raub seconded the motion. A vote was taken and the motion carried unanimously.
